CHAP. 201.

Chapter 201.

An act to authorize James A. Lancaster to construct a fish weir in Sandy Cove, in the town of Trescott.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Construction
of fish weir
authorized.

Proviso.

James A. Lancaster is hereby authorized to construct and maintain a fish weir in front of his lands in the waters of Sandy Cove, in Trescott; *provided* that such weirs shall not be constructed so as to interfere with navigation or with the rights of riparian owners.

Approved March 3, 1869.

Chapter 202.

An act to incorporate the Townsend Marine Railway Company, to be located at Boothbay.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Corporators.

Corporate name.
Powers and
privileges.

May construct
marine railway
and wharf at
Townsend harbor.

Proviso.

May hold

First meeting.

SECT. 1. Cyrus McKown, S. S. Wylie, N. C. McFarland, Eliphalet Thorp, Silas Smith, Arbor Marson, Addison W. Lewis, and William McFarland, their associates, successors and assigns, are hereby constituted a body politic and corporate by the name of the Townsend Marine Railway Company, with all the powers and privileges and subject to all the restrictions and liabilities by law incident to like corporations.

SECT. 2. Said corporation is hereby authorized to construct and maintain a marine railway and wharf at Townsend harbor, so called, in the town of Boothbay, and shall have the right to extend its works into tide waters in front of McFarland's cove, so called, not however, to exceed three hundred feet; may take and hold real and personal property not exceeding in value twenty thousand dollars.

SECT. 3. Any three of the corporators may call the first meeting of the corporation by giving personal notice to the remaining corporators, three days at least, of the time and place of meeting.

SECT. 4. This act shall take effect when approved.
