Chapter 233.CHAP. 233.

An act to incorporate the Whitman Car Stove Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. That Francis H. Whitman, John C. Brooks, Charles E. Barrett, Franklin R. Barrett and George P. Barrett, their associates, successors and assigns, are hereby created a body politic and corporate by the name of the Whitman Car Stove Manufacturing Company, for the purpose of manufacturing stoves, and also of engaging in such other branches of manufacture as may be necessarily and conveniently connected therewith, at Portland. And said corporation may exercise all the rights, powers and privileges conferred on manufacturing corporations by the laws of this state, and shall be subject to all the liabilities and restrictions thereof.

SECT. 2. The capital stock of said company shall consist of not less than ten thousand dollars, nor more than fifty thousand dollars, to be divided into shares of fifty dollars each, and said company may purchase and hold real estate to the amount of forty thousand dollars.

SECT. 3. The first meeting of said company may be called by any two of the persons named in this act, by publishing a notice stating the time, place and object of the meeting, seven days prior thereto, in one of the daily newspapers printed in Portland, or by personal notice.

First meeting, how called.

SECT. 4. This act shall take effect when approved.

Chapter 234.

An act to change the name of certain persons.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. That Caroline E. Goddard shall be allowed to take the name of Caroline E. Hacker, and George Edward Goddard shall be allowed to take the name of George Edward Hacker.

Names changed.

SECT. 2. This act shall take effect when approved.
