**CHAP. 61.** sixty-five; sixty dollars for chandelier and lighting church at Pete Dainey's point, and three hundred dollars for salary of agent of said tribe.

Approved March 8, 1869.

### Chapter 61.

Resolve in favor of the state reform school.

Reform school,  
in favor of.

*Resolved,* That the sum of one thousand dollars for painting buildings and improvement in laundry, also five hundred dollars for reservoirs and sewers, and also eleven thousand nine hundred and forty-six dollars and thirty-two cents for support of school, making in all thirteen thousand four hundred and forty-six dollars and thirty-two cents, be and is hereby appropriated for the benefit of the state reform school, for the fiscal year ending April first, in the year of our Lord one thousand eight hundred and seventy.

### Chapter 62.

Resolves making an appropriation for the Penobscot tribe of Indians.

Penobscot tribe  
of Indians, in  
favor of.

*Resolved,* That there be paid from the state treasury to the agent of the Penobscot tribe of Indians, to be appropriated for the benefit of said tribe as follows: four hundred dollars shall be expended for schools, viz., two hundred dollars on Oldtown island, under the supervision of the superintending school committee of Oldtown; one hundred and twenty dollars on Mattanawcook island, under the supervision of the superintending school committee of Lincoln; and eighty dollars on Olamon island, under the supervision of the superintending school committee of Greenbush; and said committees are required to report as directed by a resolve approved March seventeenth, eighteen hundred and sixty, and it is made the duty of the agent of said tribe to see that said money is fully expended for the education of the children of said tribe; one thousand dollars shall be expended for agricultural purposes; five hundred dollars for bounties on crops; three hundred dollars for salary of the agent of said tribe; one hundred and fifty dollars for salary of superintendent of farming on same conditions as required by chapter ninety-six of the private resolves of eighteen hundred sixty-seven; thirty dollars for salary of the governor of said tribe and twenty dollars for the salary of the lieutenant

governor; fifty dollars for the salary of priest, provided that he administer ten masses or more; two thousand dollars for the usual annuity. CHAP. 63.

*Resolved*, That there shall also be paid to said Penobscot tribe of Indians thirty-two hundred sixty-one dollars fifty-six cents, being interest on the trust fund held by the state for the benefit of said tribe, to be expended under the direction of the governor and council.

### Chapter 63.

Resolve in aid of roads and bridges in the counties of Franklin and Aroostook.

*Resolved*, That the following sums be, and the same are, hereby appropriated for building a bridge in the county of Franklin, and for repairing state roads and bridges in the county of Aroostook, viz., two hundred dollars for building a bridge across the south branch of Dead river at the place where the road, leading from Coplin plantation to Laing plantation, crosses said south branch, to be paid when said bridge is built to the satisfaction of the land agent, and accepted by him; and, also one hundred dollars for repairing state roads and bridges in plantation number eleven, in range one, in the county of Aroostook, to be expended under direction of the land agent.

Roads and bridges in Franklin and Aroostook counties, in aid of.

Approved March 9, 1869.

### Chapter 64.

Resolve in aid of the insane hospital.

*Resolved*, That there be paid out of the state treasury, from any moneys not otherwise appropriated, the sum of twenty-five thousand dollars towards the erection of a new wing to the insane hospital, to be expended under the direction of the trustees,—and the sum of six thousand dollars for the purchase of the Toby farm, so called, adjoining the hospital grounds, and the governor is hereby authorized to draw his warrant on the treasurer for the same from time to time, as it may be needed.
