**Chapter 35.**

CHAP. 35.

An act to authorize J. F. Stetson to build and maintain a wharf in tide waters of Camden harbor.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Joseph F. Stetson of Camden, in the county of Knox, his heirs, associates and assigns, are authorized and empowered to build and maintain, upon his own land in the tide waters of Camden harbor in said Camden, on the western side of said harbor, an addition to his wharf by extending the same in an easterly direction into tide waters of said Camden harbor thirty feet beyond where it now is.

Authorized to extend wharf.

SECT. 2. This act shall take effect when approved.

Approved February 2, 1872.

**Chapter 36.**

An act to authorize Tobias Roberts to extend his wharf at Bar Harbor, Mt. Desert.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Tobias Roberts is hereby authorized to extend his wharf forty feet into the tide waters at Bar Harbor, Mt. Desert.

Authorized to extend wharf.

SECT. 2. This act shall take effect when approved.

Approved February 2, 1872.

**Chapter 37.**

An act to authorize Jotham Shepherd and others to erect and maintain a wharf in tide waters of Rockport harbor.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Jotham Shepherd of Camden, in the county of Knox, his heirs, associates and assigns, are hereby authorized and empowered to build, extend and maintain, in front of his land on the western side of Rockport harbor, in said Camden, a wharf one hundred and twenty feet wide on the shore and one hundred feet at the outer front, and extending from the shore in a southeasterly direction one hundred and thirty feet into tide waters of Rockport harbor.

Authorized to build wharf.

SECT. 2. This act shall take effect when approved.

Approved February 5, 1872.
