Chapter 101.

An act to prevent the destruction of pickerel in Lovejoy's pond in Albion.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Taking pickerel by other way than hook and line prohibited.

SECT. 1. No fish known as pickerel shall be taken or fished for in the waters of Lovejoy's pond, so called, in the town of Albion, in the county of Kennebec, in any other manner than by hook and line.

Penalty for violation and how recovered.

SECT. 2. Any person who shall violate the provisions of the first section of this act, upon conviction thereof before any court of competent jurisdiction, shall forfeit and pay a fine of five dollars for every fish unlawfully taken or destroyed; one half of said fine to the use of the town of Albion and the other half to the complainant.

Act of 1861, repealed.

SECT. 3. An act entitled "An act to prevent the destruction of pickerel in Lovejoy's pond in the town of Albion," approved March fifteenth, eighteen hundred and sixty-one, is hereby repealed.

Chapter 102.

An act to set off part of letter E plantation and annex the same to the town of Madrid.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Letter E plantation, part of, set off to Madrid.

SECT. 1. That part of letter E plantation in the county of Franklin, contained in the first, second and third ranges of lots in said plantation, according to the survey and plan of Joseph Norris, is hereby set off from said plantation and annexed to the town of Madrid, in said county of Franklin.

Officers to continue in office; taxes, how collected.

SECT. 2. The officers of said letter E plantation shall hold their offices and exercise all the powers and duties of the same until others are chosen and qualified in their places; and the collectors of said plantation are authorized and required to complete the collection of all taxes already assessed the same as though this act had not been passed.

Valuation of Madrid increased.

SECT. 3. In imposing state and county taxes after the passage of this act, the valuation of the town of Madrid shall be increased to the sum of fifty-five thousand seven hundred and sixty-four dollars; and that of the plantation of letter E shall be reduced to the sum of twelve thousand nine hundred and thirty-one dollars.

Valuation letter E diminished.

SECT. 4. This act shall take effect when approved.
