## CHAP. 171.

## Chapter 171.

An act for the protection of fish in Worthley pond and Worthley brook, in the town of Poland.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Taking of fish prohibited.

SECT. 1. All persons are forbidden to take fish in Worthley pond and Worthley brook, so called, in the town of Poland in the county of Androscoggin, between the first day of April and the fifteenth day of June, and between the first day of October and the thirtieth day of November in each year.

Violations, penalty for.

SECT. 2. If any person shall violate the provisions of this act, he shall pay for each violation the sum of five dollars, to be recovered in an action of debt, one-half to the complainant and the other half to the use of the town of Poland.

SECT. 3. This act shall take effect when approved.

## Chapter 172.

An act to amend an act entitled "an act additional to the charter of the Hallowell Academy," approved February sixteenth, eighteen hundred and seventy-two.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Amendment.

SECT. 1. Section three of "an act additional to the charter of the Hallowell Academy," approved the sixteenth day of February, in the year of our Lord one thousand eight hundred and seventy-two, is hereby amended by striking out the words, "and on the same or equal conditions to," and by inserting after the words "high school," the words 'on such terms as may be agreed upon by the trustees of said academy and the city of Hallowell,' so that said section as amended shall read as follows :

Property of high school transferred to academy to revert to high school in case academy fail to comply with requirements of charter of academy.

'Sect. 3. If the trustees of the said Hallowell Classical and Scientific Academy shall fail or neglect to furnish to the inhabitants of Hallowell, facilities for the education of scholars equal to those now furnished by the Hallowell public high school, on such terms as may be agreed upon by the trustees of said academy and the city of Hallowell, all the property thus transferred and conveyed by the trustees of the Hallowell Academy shall revert to the city of Hallowell, to be used for the purposes specified in the original charter of the Hallowell academy.'

SECT. 2. This act shall take effect when approved.
