**Chapter 13.****CHAP. 13.**

Resolve establishing the valuation of the towns of Deering and Westbrook, in the county of Cumberland.

*Resolved*, That the number of polls set to the town of Deering be nine hundred sixty-one, and the value of estates two million one hundred ninety-four thousand and ninety-six dollars; and that the number of polls set to the town of Westbrook be six hundred, and the value of estates one million ninety-seven thousand and forty-eight dollars; and that all state and county taxes hereafter shall be assessed accordingly.

Approved February 7, 1872.

**Chapter 14.**

Resolves abating state tax of Veazie on one hundred and eighty-five thousand dollars.

*Resolved*, That the treasurer of state be and is hereby authorized and directed to abate one thousand one hundred and ten dollars of the state tax for eighteen hundred and seventy, assessed upon the town of Veazie, in the county of Penobscot, on one hundred and eighty-five thousand dollars taken from said town's valuation in eighteen hundred and seventy-one.

State tax on town of Veazie, abatement of.

*Resolved*, That the county commissioners for the county of Penobscot be and are hereby authorized and directed to abate two hundred and eighty-five dollars and twenty-seven cents of the county tax for eighteen hundred and seventy, assessed upon the town of Veazie in said county on one hundred and eighty-five thousand dollars taken from said town's valuation in eighteen hundred and seventy-one.

County tax 1870, abatement of.

**Chapter 15.**

Resolve in favor of Francis R. Dinsmore.

*Resolved*, That the land agent be, and he is hereby authorized to deed to Francis R. Dinsmore of Island Falls, in the county of Aroostook, lot numbered thirty-four in township number four, range four, west east line state, whenever said lot is paid for in road labor waiving further settling duties.

Lot of land to be conveyed to F. R. Dinsmore.
