**CHAP. 16.****Chapter 16.**

Resolve in favor of Spaulding Robinson and Arthur T. Robinson.

Sale of land to S. Robinson and A. T. Robinson, authorized.

*Resolved*, That the land agent be, and he is hereby authorized to sell to Spaulding Robinson and Arthur T. Robinson lots numbered one hundred and sixty-six, one hundred and seventy, one hundred and seventy-one and the east half of lot numbered one hundred and ninety, in the town of Sherman, at such price as the land agent may deem equitable and just, having reference to the improvements made by said Robinsons, the land to be paid for in road labor.

Approved February 9, 1872.

**Chapter 17.**

Resolve providing for the purchase of Maine State Year Book and Legislative Manual.

Secretary of state authorized to contract for 520 vols. Maine state year book.

*Resolved*, That the secretary of state be authorized to contract for five hundred and twenty volumes of the Maine state year book and legislative manual, bound in muslin, containing in addition to the usual matter the rules and orders, committees of the legislature and state map, at an expense not exceeding one dollar and twenty-five cents per copy; also eighty copies eight vo. for the special use of the secretary of state's office, the whole number to be furnished by May first, eighteen hundred and seventy-two.

**Chapter 18.**

Resolve in favor of Hiram Howard.

Hiram Howard, in favor of.

*Resolved*, That the land agent be, and is hereby authorized and directed to deed to Hiram Howard of Crystal plantation, county of Aroostook, the southeast quarter of section thirty-nine in Crystal plantation, county of Aroostook, agreeable to the original line, together with one hundred and eighty-four square rods from the northeast quarter of the same section, agreeable to the award of Jacob Saunders and William Young, when said Howard shall have paid for the same and performed all other duties required under the settling act.
