Chapter 146.

An act to authorize the city of Rockland to retire or exchange its bonded indebtedness, and to issue new bonds for that purpose.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The city of Rockland is hereby authorized to City of Rockland retire, by purchase or exchange, at the option of the holder, its bonded indebtedness, either at or before the maturity thereof, and for this purpose to issue new bonds in such form and amount, and with such rates of interest, and payable at such times and manner, as shall be determined by a majority concurrent vote of the board of aldermen and common council of said city; provided, however, that nothing herein con- Proviso. tained shall authorize any increase in the indebtedness of said city.

To carry into effect the provisions and purposes Authorized to of this act, said city is hereby authorized to pass such votes by its board of aldermen and common council, concurrently, as may be deemed necessary and proper; to enter into and make any contract or agreement not inconsistent with the laws of this state.

SECT. 3. This act shall take effect when approved.

Chapter 147.

SECT. 1.
