#### Chapter 317.

An Act to incorporate the town of Bancroft.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The plantation of Bancroft in the county of Aroostook, is Incorporation of town of Banhereby incorporated into a town to be known as the town of croft. Bancroft.

Approved February 5, 1889.

#### Chapter 318.

An Act to change the name of Stockton to Stockton Springs.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The name of the town of Stockton, in the county of Waldo, Name changed to Stockton is hereby changed to Stockton Springs.

#### Chapter 319.

An Act to incorporate the Augusta Safe Deposit and Trust Cempany.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Darius Alden, John W. Chase, Treby Johnson, Corporators, G. C. Vose, H. M. Heath, their associates and successors, are hereby made a corporation by the name of the Augusta Corporate name. Safe Deposit and Trust Company, for the purpose of receiving Powers. on deposit, money and other personal property of every description, and of collecting and disbursing the income and principal of said property when due; of receiving on deposit for safe keeping, money, securities, stocks and other property of every kind; of loaning or advancing money or credits on real and personal securities; of selling and disposing of the securities held by it; of guaranteeing the payment of principal and interest; of all obligations secured by mortgage or deed of trust of real estate running to said corporation; to issue bonds or debentures secured by assignment of mortgages on
