SECT. 7. Nothing in this act shall deprive the legislature of the right to alter, amend or repeal this charter.

Chapter 269.

An Act to authorize the Thomaston Street Railway Company to extend its railroad to Saint George.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The Thomaston Street Railway Company is Company, authorized to hereby authorized to construct, operate and maintain a street construct a railroad from Wyllie's corner in the town of Saint George, thence over the county road to the boundary line of Thomas- -route. ton, subject to all the restrictions and limitations of its existing charter and with all the powers and privileges thereby conferred.

SECT. 2. This act shall take effect when approved.

Chapter 270.

An Act to amend chapter one hundred and seventy-nine of the Private and Special Laws of eighteen hundred and sixty-seven of the state of Maine, entitled "An Act for the protection of tront in Cathance Lake, Washington county."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The fifth line of said chapter is hereby amended as follows: strike out the word "December" and insert instead the word 'June,' so that said chapter shall read as follows:

Ch. 179, Laws of 1867, amended.

'If any person shall fish with hook and line, gaff, seine, or with any other tackle in Cathance lake or its tributary brooks or streams in the town of Cooper and Plantation number and June 30, prohibited. fourteen, eastern division in Washington county, between the first day of October and the last day of June, he shall forfeit three dollars; and if any person shall take or destroy any -penalty.

-penalty, for putting pike or pickerel in said lake.

trout in said lake or its tributary brooks or streams during the time aforesaid, he shall forfeit the sum of five dollars for each trout so taken or destroyed, and if any person shall put into said lake or its tributary brooks or streams, any pike or pickerel or any other fish destructive to trout, he shall forfeit fifty dollars, said penalties to be recovered in action of debt, one-half thereof to the town or plantation where the offense is committed and one-half to the complainant; and in default of payment he shall be committed to the county jail for a term of six months, or until the same be paid.'

Chapter 271.

An Act to incorporate the New Sharon Cemetery Improvement Association.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

SECT. 1. H. B. Prescott, Z. A. Dyer, W. W. Norcross, Rosetta A. Curtis, James W. Smith, Frederick Swan, Jabez S. Mooers, Charles W. Thompson, and Horace Soule, their associates and successors, are hereby constituted a body corporate under the name of New Sharon Cemetery Improvement Association, and under that name shall have power to prosecute and defend suits at law, take and hold for the objects of their association, by gift, grant, bequest, purchase or otherwise, any estate, real or personal, and to sell and convey the same, as the interests of the said association may require.

Shall perform all duties imposed any legacy.

Having accepted any donation or legacy, said by acceptance of association as trustee shall be legally bound to perform the duties specified in the writing creating the trust, or as required by law, if not so specified, and as in cases of public charity.

How trust funds sha l be

SECT. 3. All trust funds authorized by this act shall be safely invested in legal securities and depositories, and the annual income only shall be expended in the performance of the requirements of the trust unless otherwise designated.
