CHAP. 569

Chapter 569.

An Act for the protection of Pickerel and Bass in Pleasant Pond in Turner.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Taking of fish from Pleasant pond for four years, prohibited.

SECT. 1. No person shall take, catch, kill, fish for, or destroy any pickerel or bass in Pleasant Pond or its tributaries or outlet, in the town of Turner, county of Androscoggin, from October first to June first, for the period of four years.

Penalty.

SECT. 2. Any person who shall violate the provisions of this act shall forfeit and pay the sum of ten dollars for the offense, and one dollar for each and every such fish so taken, caught, killed or destroyed; to be recovered by complaint before any municipal court or trial justice in said county, one-half to the complainant and one-half to the county where proceedings are commenced.

Approved March 27, 1893.

Chapter 570.

An Act to amend chapter two hundred and eighty-one of the Private and Special Laws of eighteen hundred and ninety-one, relating to fishing in East, North McGraw, Ellis, Long, Great or Snow ponds.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Sec. 1, ch. 281, Private Laws of 1891, amended.

Section one of chapter two hundred and eighty-one of the private laws of eighteen hundred and ninety-one is hereby amended, so as to read as follows :

Taking of fish from certain ponds for four years, prohibited.

‘SECT. 1. No land-locked salmon or trout shall be taken by any person in any way whatever, from East, North, McGraw, Ellis, Long, Great or Snow ponds, situated in the counties of Kennebec and Somerset, or from any streams flowing into or out of either of said ponds, for a period of four years from the first day of May, eighteen hundred and ninety-three.’

Approved March 27, 1893.
