Chapter 99.

An Act to incorporate the Knox County General Hospital.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

Section 1. A. F. Crockett, W. T. White, L. B. Keen, Elmer S. Bird, John Lovejoy, E. S. Farwell, S. T. Kimball, M. S. Bird, F. R. Spear, John F. Gregory, W. M. Spear, F. B. Adams. C. A. Crockett, John T. Berry, Thomas Hawken, N. F. Cobb. J. H. McNamara, A. R. Smith, S. M. Bird, W. H. Bird, W. W. Case, F. A. Thorndike, H. I. Hix, N. T. Farwell, E. A. Burpee, W. W. Spear, E. A. Butler, S. W. McLoon, John Bird, W. S. White, A. J. Bird, E. K. Glover, E. F. Glover and F. W. Fuller of Rockland in the county of Knox; J. M. Wakefield, George Walker and N. B. Eastman of Warren; W. G. Alden, W. F. Hart, S. G. Ritterbush, E. W. Boynton, C. W. Follansbee, Williston Grinnell and W. E. Schwartz of Camden; H. L. Shepherd, J. H. Carleton, R. W. Carleton, Frank Carleton and S. Y. Weidman of Rockport; John E. Walker, P. M. Studley. J. E. Moore and Edwin Smith of Thomaston; G. C. Horn and F. M. Smith of South Thomaston; Willis Adams of Saint George, their associates and successors, are hereby incorporated and made a body politic by the name of the Knox County General Hospital, and by that name may sue and be sued, may have a common seal, and shall have all the immunities and privileges and be subject to all the liabilities of like corporations.

-corporate

May hold lands, tenements, etc.

Section 2. Said corporation may take, receive, purchase, hold and possess lands and tenements in fee simple or otherwise, and dispose of and sell the same, and may receive of and from all persons disposed to aid its benevolent purposes, and grants and devises of real estate, and any donations, subscriptions, and bequests of money, or other property, to be used for the erection, support and maintenance of a general hospital for the sick, to be located within the city of Rockland.

May establish by-laws and regulations. Section 3. The said corporation shall have the power to make and establish such by-laws and regulations as may be necessary for the choice of proper officers, to prescribe their duties and powers, and to provide generally for the internal government and economy of the hospital, such by-laws and regulations not being repugnant to the constitution and by-laws of this state.

May establish training school for nurses. Section 4. The said corporation is authorized to establish a training school for nurses, and to issue diplomas as shall be fit and proper.

Section 5. This act shall take effect when approved.
