**Chapter 4.**

An Act to extend the charter of the Merchants' Trust Company.

*Be it enacted by the People of the State of Maine, as follows:*

The rights, powers and privileges of the Merchants' Trust Company, located at Auburn, Androscoggin county, Maine, which were granted by chapter sixteen of the private and special laws of nineteen hundred and seven, approved February six, nineteen hundred and seven, are hereby extended for one year from the approval of this act, and George C. Wing, John H. Litchfield, Seth M. Carter, George C. Wing, Jr., David R. Hastings, and Everett L. Smith, their associates and successors, shall have all the rights, powers and privileges that were granted by said original act, to be exercised in the same manner and for the same purposes as specified therein; provided, however, that said company shall actually commence business as a trust company within said one year.

**Chapter 5.**

An Act to extend the charter of the Central Aroostook Electric Company.

*Be it enacted by the People of the State of Maine, as follows:*

The time within which the Central Aroostook Electric Company, chartered under chapter two hundred and sixty-four, private laws of nineteen hundred and seven, shall actually commence business under its charter, is hereby extended two years from the date when this act shall take effect.

**Chapter 6.**

An Act to extend the charter of the Northern Aroostook Electric Company.

*Be it enacted by the People of the State of Maine, as follows:*

The time within which the Northern Aroostook Electric Company, chartered under chapter two hundred and sixty-three, private laws of nineteen hundred and seven, shall actually commence business under its charter, is hereby extended two years from the date when this act shall take effect.
