Chapter 10.

Resolves, authorizing a Temporary Loan for the year nineteen hundred and ten.

Tempo-
rary loan
authorized
for 1910.

Resolved, that to provide for the wants of the treasury, the treasurer of state be and is hereby authorized to procure on the faith of the state, if he shall deem it necessary, at any time during the year nineteen hundred and ten, a temporary loan of three hundred thousand dollars or so much thereof as may be needed.

State
treasurer
may give
notes for.

Resolved, that the treasurer of state be and hereby is authorized to give notes in behalf of the state, payable within three years from the date hereof, for such portions of the loan hereby authorized as may be required.

Chapter 11.

Resolve in favor of the Maine Institution for the Blind.

Maine

Resolved, that the sum of fifteen thousand dollars be and hereby is appropriated to the Maine Institution for the Blind for the year nineteen hundred and nine and a like sum for the year nineteen hundred and ten, to be expended by the officers of said institution in finishing, furnishing and equipping its buildings now being constructed; and for purchase of necessary tools, apparatus and materials for the operation thereof; and for the maintenance of said institution.

The officers of said institution in furtherance of the purposes of this resolve may provide and pay for temporary lodgings and support of workmen or pupils received at its industrial school or workshop and may ameliorate the condition of the blind by industrial training, the circulation of books, promoting visits among the aged or helpless blind in their homes, and by such other methods as they may deem expedient; provided that it shall not undertake the permanent support or maintenance of any blind person at the expense of the state.

Chapter 12.

Resolve in favor of the Maine Eye and Ear Infirmary.

Resolved, that there be and hereby is appropriated annually, the sum of five thousand dollars, to be paid to the treasurer of the Maine Eye and Ear Infirmary for the use of said institution for the years nineteen hundred and nine, and nineteen hundred and ten.
