**Chapter 17.**

Resolve in favor of the Maine Home for Friendless Boys.

Resolved, that there be and hereby is appropriated four thousand dollars for the use of the Maine Home for Friendless Boys at Portland; two thousand dollars for the year nineteen hundred and nine and two thousand dollars for the year nineteen hundred and ten.

**Chapter 18.**

Resolve in favor of the Holy Innocents' Home for Infants in the City of Portland.

Resolved, that there be and is hereby appropriated the sum of five thousand dollars to be paid to the Holy Innocents' Home of Portland, for the use of the said institution; two thousand five hundred dollars to be appropriated for the use of said institution for the year nineteen hundred nine and two thousand five hundred dollars to be appropriated for the use of said institution for the year nineteen hundred ten.

**Chapter 19.**

Resolve in favor of the Eastern Maine General Hospital.

Resolved, that there be and is hereby appropriated the sum of five thousand dollars to be paid to the Eastern Maine General Hospital for the use of said institution for the year nineteen hundred nine, and five thousand dollars for the use of said institution for the year nineteen hundred ten.

**Chapter 20.**

Resolve in favor of the Central Maine General Hospital of Lewiston.

Resolved, that the sum of six thousand five hundred dollars be and is hereby appropriated for the benefit of the Central Maine General Hospital at Lewiston for the year one thousand nine hundred and nine, and the sum of six thousand five hundred dollars for the year one thousand nine hundred and ten, for maintenance.
