**Chapter 27.**

Resolve in favor of Bridgewater Classical Academy.

Resolved, that there be and hereby is appropriated the sum of five hundred dollars to be paid to the trustees of Bridgewater Classical Academy situated in the town of Bridgewater, County of Aroostook.

**Chapter 28.**

Resolve in favor of L. M. Staples, chairman committee on Home for Feeble Minded.

Resolved, that there be appropriated and paid to L. M. Staples, chairman of the committee on Home for Feeble Minded, the sum of sixty dollars, the same being for expenses of the committee to visit said institution.

**Chapter 29.**

Resolve providing for assistance in rebuilding the East Branch bridge in the town of Oakfield.

Resolved, that there be and is hereby appropriated the sum of seven hundred and fifty dollars to aid in rebuilding the bridge across the east branch of the Mattawamkeag river near Oakfield station in the town of Oakfield, Aroostook county, provided that the amount herein appropriated be expended under the direction of the state highway commissioner and the Aroostook county commissioners, and provided further that the appropriation of seven hundred and fifty dollars be conditional upon the expenditure of a like sum by the town of Oakfield.

**Chapter 30.**

Resolve in favor of Knox County General Hospital.

Resolved, that there be and hereby is appropriated the sum of two thousand dollars to be paid to the Knox County General Hospital for the general use of said institution for the year nineteen hundred and nine, and two thousand dollars for the year nineteen hundred and ten; also an additional sum of two thousand dollars for the year nineteen hundred and nine for the purpose of equipment, maintenance and repair or of additions to its buildings, grounds and apparatus.
