**Chapter 56.**

Resolve in favor of E. and I. K. Stetson, Agents.

Resolved, that the sum of one hundred sixty-one dollars twenty-five cents be paid to E. and I. K. Stetson, agents, of Bangor, Maine, for one-half rental due them from money collected by the land agent in township three, range four, Franklin county.

**Chapter 57.**

Resolve in favor of Honorable George H. Eaton, chairman of the committee on appropriations and financial affairs.

Resolved, that there be and hereby is appropriated, to be paid to Honorable George H. Eaton, chairman of the committee on appropriations and financial affairs, the sum of forty-three dollars and sixteen cents to pay the expenses of said committee on its visits of inspection to state institutions and general hospitals in the city of Portland and to the Maine State Sanitorium in the town of Hebron.

**Chapter 58.**

Resolve in favor of the town of Cornville.

Resolved, that there be paid to the town of Cornville the sum of fifteen dollars and seventy-five cents, it being the amount due said town for tuition of pupils in secondary schools for the years nineteen hundred and four, nineteen hundred and five and nineteen hundred and seven, but not reported by that town in those years.

**Chapter 59.**

Resolve in relation to Fort William Henry in the town of Bristol.

Resolved, that there be and hereby is appropriated the sum of fifteen hundred dollars for the use of the Pemaquid commissioners, the same to be used in completing and furnishing the memorial tower of Fort William Henry, and for such other purposes connected with the care of the reservation and state property thereunto appertaining as may, in their judgment be necessary.
