Resolve in favor of the Camden and Rockland Water Company.

Resolved, that the sum of twelve hundred and fifty dollars is hereby appropriated to be paid to the Camden and Rockland Water Company, in payment of amount due said company for water furnished the Maine state prison, from July first, nineteen hundred and eight to January first, nineteen hundred and nine.

**Chapter 102.**

Resolve in favor of the Maine Industrial School for Girls, for water supply and grading.

Resolved, that there be and hereby is appropriated to be paid the Maine Industrial School for Girls the sum of two thousand dollars for the year nineteen hundred and nine for providing for a suitable water supply; also the sum of five hundred dollars for the year nineteen hundred and nine and five hundred dollars for the year nineteen hundred and ten for grading and draining the grounds and the construction of roadways.

**Chapter 103.**

Resolve to provide for the expenses of the Maine Industrial School for Girls.

Resolved, that there be and hereby is appropriated to be paid the Maine Industrial School for Girls the sum of eighteen thousand dollars for the year nineteen hundred nine and the sum of eighteen thousand dollars for the year nineteen hundred ten for general expenses; also the sum of three thousand dollars for the year nineteen hundred nine for deficiency of the year nineteen hundred eight.
