**Chapter 172.**

Resolve in favor of the Eastern Maine Insane Hospital, for fire-proof building.

Resolved, that there be and hereby is appropriated the sum of eighty-seven thousand five hundred dollars for the year nineteen hundred and nine, and eighty-seven thousand five hundred dollars for the year nineteen hundred and ten, to construct a fire-proof building for male patients at the Eastern Maine Insane Hospital, and a further sum of twelve thousand dollars for the year nineteen hundred and ten, to furnish and equip the building for one hundred and fifty patients.

Said sums to be expended under the direction of the trustees of insane hospitals.

Approved March 16, 1909.

**Chapter 173.**

Resolve in favor of a highway bridge over Saint John River, between Van Buren and Saint Leonards, New Brunswick.

Resolved, that the sum of thirty-seven thousand five hundred dollars be and hereby is appropriated, one-half in the year nineteen hundred nine, and one-half in the year nineteen hundred ten, to meet not to exceed one-half the cost of constructing a highway bridge over the Saint John river, between the town of Van Buren, Aroostook county, and the village of Saint Leonards, Madawaska county, New Brunswick.

Provided, that the expenditure of this amount shall not be made unless the dominion of Canada or the province of New Brunswick furnish and expend an amount sufficient to meet one-half the cost of construction of said bridge.

Proviso.

Said bridge shall be built of steel or iron of sufficient width to accommodate traffic, upon substantial piers and abutments of masonry.

Said appropriation shall be expended under the direction of the state commissioner of highways, acting in concert with such person or persons as may be designated by the dominion of Canada or the province of New Brunswick.

Approved March 18, 1909.
