**CHAP. 292****Chapter 292.**

Resolve in favor of the Plantation of Magalloway in Oxford County.

Resolved, that there be and hereby is appropriated to the plantation of Magalloway, in Oxford County, the sum of seventy-seven dollars and sixty-three cents, this sum being the amount forfeited to the state by the neglect of said plantation to make certain required reports.

**Chapter 293.**

Resolve in favor of H. M. Sewall, Chairman of Committee on Salaries and Fees, in payment of Counsels' and Witnesses' Fees, Stenographers, services, and disbursements made by him in the matter of the investigation of the State and Town Liquor Agencies.

Resolved, that the sum of eighteen hundred and ninety and seven one hundredths dollars, is hereby appropriated and that the state treasurer be and is hereby authorized and directed to pay said sum of eighteen hundred and ninety and seven one hundredths dollars to H. Sewall, chairman of committee on salaries and fees, for counsels' and witnesses' fees, stenographers, services and disbursements made by him in the matter of the investigation of the state and town liquor agencies.
