## CHAP. 127

**Chapter 127.**

An Act Relating to Crossings of the Rights of Way of Railroads Organized under Chapter Fifty-three of the Revised Statutes.

*Be it enacted by the People of the State of Maine, as follows:*

Certain sections of previous chapters made applicable to crossings of rights of way of railroads organized under chapter 53, R. S.

Sections twenty-nine to thirty-two, both inclusive, of chapter twenty-three of the Revised Statutes, as amended by chapter one hundred twenty-nine of the Public Laws of nineteen hundred thirteen, creating a Public Utilities Commission, and sections sixty-five to seventy-two, both inclusive, of chapter fifty-one of the Revised Statutes, as amended by said chapter one hundred twenty-nine of the Public Laws of nineteen hundred thirteen, and chapter twenty-two of the Public Laws of nineteen hundred nine, as amended by said chapter one hundred twenty-nine of the Public Laws of nineteen hundred thirteen, are hereby made applicable to crossings of the private right of way of railroads organized under chapter fifty-three of the Revised Statutes, and to crossings of streets and ways occasioned by the construction of such railroads outside the limits of streets, roads and ways.

**Chapter 128.**

An Act to Amend Section Two of Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Fishing in the Pool at Upper Dam and in the River Running from said Pool to Lake Mollychunkamunk, in the County of Oxford.

*Be it enacted by the People of the State of Maine, as follows:*

Fishing permitted during a certain period.

So much of section two of chapter thirty-two of the Revised Statutes, as amended by chapter two hundred six of the Public Laws of nineteen hundred thirteen, as prohibits fishing in the ordinary way of angling with artificial flies, or fly fishing, in the pool at Upper dam and in the river running from said pool to Lake Mollychunkamunk, in the county of Oxford, from September fifteenth to September thirtieth of each year, both days inclusive, is hereby repealed.
