## CHAP. 186

**Chapter 186.**

An Act Additional to Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Fishing in Ellis Pond, in Somerset County.

*Be it enacted by the People of the State of Maine, as follows:*

Ellis pond closed to fishing during September of each year.

No person shall fish for, take, catch or kill any kind of fish, at any time during the month of September of each year, in that part of Ellis pond lying southerly of the boat landing on the west side of said pond and southerly of the first point above the outlet on the east side of said pond, which pond is situated in the west part of township number one, range six, Bingham's Kennebec Purchase, West Kennebec river, known as the ten thousand acre tract, in Somerset county. No person shall have in possession, at any time, any kind of fish taken in violation of any provision of this act. Whoever violates any provision of this act shall pay a fine of not less than ten dollars nor more than thirty dollars and costs for each offense; and in addition thereto one dollar for each fish taken, caught, killed or had in possession in violation of any provision of this act.

**Chapter 187.**

An Act Additional to Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Ice Fishing in Ross Lake and in Cary Lake, in Littleton, in Aroostook County.

*Be it enacted by the People of the State of Maine, as follows:*

Ice fishing prohibited in Ross and Cary lakes.

No person shall fish for, take, catch or kill any kind of fish at any time on or through the ice in Ross lake or in Cary lake, in Littleton, in the County of Aroostook; nor shall any person have in possession at any time any kind of fish taken on or through the ice in either of said lakes. Whoever violates any provision of this act shall pay a fine of not less than ten dollars nor more than thirty dollars and costs of prosecution for each offense; and in addition thereto one dollar for each fish taken, caught, killed or had in possession in violation of any provision of this act.
