## CHAP. 213

**Chapter 213.**

An Act to Amend Section Two of Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Relating to Ice Fishing in Barker Pond, in Cornville, in Somerset County.

*Be it enacted by the People of the State of Maine, as follows:*

Ice fishing  
in Barker  
pond per-  
mitted.

So much of section two of chapter thirty-two of the Revised Statutes, as amended by chapter two hundred six of the Public Laws of nineteen hundred thirteen, as prohibits fishing through the ice in Barker pond, in Cornville, in Somerset county, in accordance with the general law of the State relating to ice fishing, is hereby repealed.

Approved March 29, 1915.

**Chapter 214.**

An Act Additional to Chapter Thirty-two of the Revised Statutes, as Amended by Chapter Two Hundred Six of the Public Laws of Nineteen Hundred Thirteen, Prohibiting Ice Fishing in Pleasant Pond, Mud Pond, Horseshoe Pond and Oxbow Pond, Situated in the Counties of Kennebec and Sagadahoc.

*Be it enacted by the People of the State of Maine, as follows:*

Certain  
waters of  
Kennebec  
and Saga-  
dahoc coun-  
ties closed  
to ice  
fishing.

No person shall fish for, take, catch or kill any kind of fish at any time on or through the ice in Pleasant pond, so-called, in the towns of West Gardiner and Litchfield and in the city of Gardiner, in the county of Kennebec, and in the town of Richmond, in the county of Sagadahoc; or in Mud pond, so-called, situated in said town of Litchfield and in said town of Richmond, or in Horseshoe pond, so-called, or in Oxbow pond, so-called, situated in said town of West Gardiner. No person shall have in possession at any time any kind of fish taken in violation of any provision of this act. Whoever violates any provision of this act shall pay a fine of not less than ten dollars nor more than thirty dollars and costs for each offense; and in addition thereto one dollar for each fish taken, caught, killed or had in possession in violation of any provision of this act.
