Chapter 44.

Resolve in Favor of Edgar S. Fossett, Secretary of the Committee on State Prison, for Certain Committee Expenses.

Edgar S. Fossett, in favor of.

Resolved, That there be, and hereby is, appropriated the sum of ninety-eight dollars to be paid to Edgar S. Fossett, secretary of the Committee on State Prison, for expenses incurred by said committee in visiting the State Prison at Thomaston.

Chapter 45.

Resolve in Favor of the Clerk, Assistant Clerk, Messenger, Assistant Messenger, Mail Carrier, First Folder, Assistant Folder, Doorkeeper, and Pages of the Seventy-sixth Legislature for Attendance at the Organization of the Seventy-seventh Legislature.

Officials at organization of Seventy-seventh Legislature, in favor of.

Resolved, That there be, and hereby is, appropriated to be paid to each of the following officers for attendance at the organization of the Seventy-seventh Legislature, the amounts set against their respective names, amounting to the sum of three hundred and sixty-one dollars:

Jas. L. Bresnahan, page, service, fifteen dollars; mileage, twenty-one dollars.

C. H. Ashford, doorkeeper, service, fifteen dollars; mileage, one dollar.

Ralph R. Baker, page, service, fifteen dollars; mileage, twenty-five dollars.

S. R. Purinton, assistant folder, service, fifteen dollars; mileage, seventeen dollars.
