Chapter 48.

Resolve, in Favor of the National Conference of Commissioners on Uniform State Laws and of the Commissioners from Maine for the Promotion of Uniformity of Legislation in the United States.

National Conference of Commissioners on Uniform State Laws. Resolved: That the sum of five hundred dollars for the year nineteen hundred and nineteen, and the sum of five hundred dollars for the year nineteen hundred and twenty, be, and hereby is, appropriated; two hundred dollars each year to be paid to the National Conference of Commissioners on Uniform State Laws, and so much of the balance of three hundred dollars each year as may be necessary to be paid to the commissioners of Maine for the promotion of uniformity of legislation in the United States for their expenses in attending the National Conference of Commissioners on Uniform State Laws, for drafting and printing reports, postage, and for their other expenses in performing the duties of said office.

Approved March 14, 1919.

Chapter 49.

Resolve, in Favor of the University of Maine for Maintenance.

University of Maine, for maintenance. Resolved: That there be, and hereby is, appropriated in favor of the University of Maine the sum of one hundred and eighty thousand dollars for the year nineteen hundred and nineteen, and the sum of one hundred and eighty thousand dollars for the year nineteen hundred and twenty, for maintenance.

Chapter 50.

Resolve, Making Appropriations for the Passamaquoddy Tribe of Indians for the Years Nineteen Hundred and Nineteen and Nineteen Hundred and Twenty.

Emergency preamble. Resolved: Whereas, the State of Maine holds in trust for the Passamaquoddy tribe of Indians a certain large sum of money to wit; ninety-nine thousand eight hundred and five dollars and sixteen cents, and whereas all funds appropriated by the seventy-eighth legislature for the care, maintenance and relief of said tribe have been expended for the purposes and in the manner prescribed by law, and because of the lack of available funds, said tribe may fall into distress and be deprived of proper food, shelter and clothing, and;

Whereas, by reason of the foregoing facts the appropriation called for in this resolve is immediately necessary for the preservation of the public peace, health and safety, and in the opinion of this legislature constitutes an emergency as contemplated in the constitution, be it therefore

Resolved: That there be paid from the state treasury, to be expended under the direction of the governor and council, to the agent of the Passamaquoddy tribe of Indians for the benefit of said tribe for the years nineteen hundred and nineteen and nineteen hundred and twenty, as follows:

Making a total of twenty-two thousand five hundred and thirty-five dollars for the year nineteen hundred and nineteen and nineteen thousand nine hundred and eighty-five dollars for the year nineteen hundred and twenty.

In view of the emergency cited in the preamble, this resolve shall take effect when approved.

Chapter 51.

Resolve, in Aid of Navigation on Sebec Lake in Piscataquis County.

Sebec lake, Piscataquis county, buoys and lights. **Resolved:** That the sum of three hundred dollars be, and hereby is, appropriated for the following purposes, to wit: The placing and improvement of buoys, the erection of lights, and the maintenance of the same in Sebec lake, in Piscataquis county, being a part of the inland waters of the State of Maine, as hereinafter set forth, the sum of one hundred and fifty dollars for the year nineteen hundred and nineteen and the sum of one hundred and fifty dollars for the year nineteen hundred and twenty. Said moneys shall be expended under the supervision of the state steamboat inspectors, and any part of the money hereby appropriated, which should be unexpended at the end of the year nineteen hundred and twenty, shall revert back to the state.

Resolve, in Favor of the State School for Boys.

State School for Boys. **Resolved:** That there be, and hereby is, appropriated for maintenance and other purposes for the State School for Boys the following sums:
