## Chapter 51.

An Act Relating to the Salary of the Adjutant General.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 117, sec. 26; relating to the adjutant general, amended. Section twenty-six of chapter one hundred and seventeen of the revised statutes as amended by chapter seventy-nine of the public laws of nineteen hundred and twenty-one is hereby further amended by striking out the words "twenty-five hundred" in the second line thereof and inserting in lieu thereof 'four thousand' so that said section as amended will read as follows:

'Sec. 26. Salary four thousand dollars. The adjutant general shall receive an annual salary of four thousand dollars; he shall receive no other fee, emolument or perquisite.'

## Chapter 52.

An Act Relating to Clerk Hire in the Office of Register of Deeds for Knox County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 117, sec. 45; as amended; relating to clerk hire in county offices, further amended. Section forty-five of chapter one hundred and seventeen of the revised statutes, as amended, is hereby further amended by striking out in the eighth paragraph thereof after the words "register of deeds" the words "seven hundred and eighty dollars" and inserting in place thereof the words 'nine hundred and thirty-six dollars,' so that said paragraph, as amended, insofar as it relates to clerk hire in the office of the register of deeds of Knox county, shall read as follows:

Clerk hire in the office of register of deeds in Knox county increased. 'for clerks in the office of the register of deeds, nine hundred and thirty-six dollars.'

R. S., c. 64, sec. 58; P. L., 1917, c. 176; relating to persons maintaining homes for children; further amended. Section fifty-eight of chapter sixty-four of the revised statutes, as amended by chapter one hundred and seventy-six of the public laws of nineteen hundred and seventeen, is hereby
