## Chapter 340.

An Act to Close to Fishing in the Tributaries to Long and Square Ponds.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Close time on tributaries to Long and Square pond.** It shall be unlawful to fish for, take, catch or kill any kind of fish, at any time in the tributaries to either Long pond or to Square pond, both in the towns of Shapleigh and Acton, in the county of York.

**Sec. 2. Penalty for violations.** Whoever violates the provision of this act shall pay a fine of not less than ten, nor more than thirty dollars, and costs of prosecution, for each offense; and in addition thereto one dollar for each fish taken, caught, killed or had in possession in violation of any provision of said sections.

**Sec. 3. Inconsistent acts repealed.** All acts, parts of acts, rules and regulations inconsistent herewith are hereby repealed.

## Chapter 341.

An Act to Prohibit the Trapping of Muskrat in Sourdabscook Stream in the Town of Carmel.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Trapping of muskrats in Sourdabscook stream prohibited.** It shall be unlawful for any person to trap any muskrat or muskrats in Sourdabscook stream from the point where the state highway crosses said stream in the village of Carmel in the town of Carmel, to its junction with the Penobscot river, or in any of the tributaries to said stream between the two points hereintofore mentioned. It shall also be unlawful during the same period for any person to have in possession at any time any muskrat or muskrats, or any part or parts thereof, taken in any of the above-named waters.

**Sec. 2. Penalty for violations.** Whoever violates any provision of this act shall pay a fine of ten dollars and costs for each offense, and in addition thereto three dollars for each muskrat or part thereof hunted, trapped, killed, pursued, caught or had in possession in violation of any provision of this act.
