## Chapter 75.

Resolve, in Favor of the Town of New Sharon.

**New Sharon, town of, for bridge. Resolved:** That there be appropriated the sum of eighteen hundred forty-four dollars and fifteen cents to reimburse the town of New Sharon for the maintenance and repairs of the New Sharon bridge, said funds to come from highway maintenance funds.

Approved April 1, 1929.

## Chapter 76.

Resolve, in Favor of the Town of Salem, for a New Bridge.

**Salem, town of, for new bridge. Resolved:** That there be, and hereby is, appropriated to be paid to the town of Salem, for the construction of a new bridge over the south branch of the Carrabassett river in Salem village, the sum of one thousand three hundred and three dollars and ninety-five cents, the same being the apportionment made to said town for the construction thereof and is to be taken from the "Bridge Loan Fund," so-called, and the bridge is to be constructed under the bridge act.

## Chapter 77.

Resolve, in Favor of the Towns of Sangerville and Guilford.

**Sangerville and Guilford, towns of, reconstruction of bridge. Resolved:** That there be and hereby is appropriated, from the bridge loan fund, the sum of five thousand six hundred dollars to aid the town of Sangerville, and eight thousand six hundred dollars to aid the town of Guilford in the reconstruction of Sangerville station bridge, between the towns of Sangerville and Guilford; these amounts to be applied as the towns' portions of the cost of the work, under the bridge act.

## Chapter 78.

Resolve, in Favor of the Northern Maine Sanatorium for the Construction and Equipment of a Nurses' Home.

**Northern Maine Sanatorium, for nurses' home. Resolved:** That there be, and hereby is, appropriated for the Northern Maine Sanatorium the sum of forty-five thousand dollars for the construction and equipment of a nurses' home, said sum to be available from surplus revenue funds.

Approved April 2, 1929.
