**CHAP. 83**

'Whoever violates any of the ~~foregoing~~ provisions of this chapter or ~~and~~ rules and regulations promulgated thereunder, or rules and regulations heretofore promulgated and still in force and effect, excepting only those for the violation of which specific penalties have been hereinbefore provided, may be punished by a fine of not less than \$10 or not more than \$300 and costs, or by imprisonment for not more than 90 days, or by both said fine and imprisonment, except as hereafter noted.'

**Chapter 82.****AN ACT Relative to the Use of Live Decoys and Boats in Hunting Waterfowl.**

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 38, § 57, ¶ 2, amended. Paragraph 2 of section 57 of chapter 38 of the revised statutes, is hereby amended to read as follows:

'No boat shall be allowed on or in any ~~said~~ waters for hunting purposes earlier than one and one-half hour before sunrise, nor shall any duck decoys be allowed to remain in said waters between the hour of sunset and one hour before sunrise.'

**Chapter 83.****AN ACT Relating to Ice Fishing in Sandy Pond, in Freedom and Montville, in the County of Waldo.**

*Be it enacted by the People of the State of Maine, as follows:*

**Ice fishing in Sandy pond regulated.** The commissioner of inland fisheries and game is hereby directed to issue a rule and regulation forbidding any person to fish for, take, catch or kill any kind of fish at any time on or through the ice in the waters of Sandy pond, said pond being located in the towns of Freedom and Montville, in the county of Waldo; except on Tuesday of each week, during the months of January, February and March of each year, and forbidding any person to take more than 5 fish in any 1 day when fishing in Sandy pond, in accordance with the provisions of this rule and regulation, and forbidding any person to have in possession at any time any fish taken in violation of any provision of this rule and regulation.
