## Chapter 19.

### AN ACT to Amend an Act to Incorporate the Guilford and Sangerville Water District.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1911, c. 201, § 16, amended. Section 16 of chapter 201 of the private and special laws of 1911, as amended by section 10 of chapter 81 of the private and special laws of 1929, as further amended by section 2 of chapter 82 of the private and special laws of 1931, is hereby further amended to read as follows:

'Sec. 16. Acquisition of properties necessary to make act valid. If said water district shall fail to acquire the plant, properties, franchises, rights and privileges owned by said Guilford Water Company and Sangerville Water Supply Company, aforesaid, by purchase, or to file its petition to take the same by the exercise of the right of eminent domain as hereinbefore provided, in either case before the 1st day of July, ~~1933~~, 1936, this act shall become null and void. Said district shall not begin to furnish water under this act until it shall have acquired the properties of said Guilford Water Company and Sangerville Water Supply Company, as hereinbefore provided.'

## Chapter 20.

### AN ACT Relating to Taking of Land for Park Purposes by Parsonsfield Kezar Falls Village Corporation.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1911, c. 216; P. & S. L., 1923, c. 12, relating to Parsonsfield Kezar Falls Village Corporation may take land for park purposes, further amended. Chapter 216 of the private and special laws of 1911, as amended by chapter 12 of the private and special laws of 1923, is hereby further amended by adding thereto another section, to read as follows:

'Sec. 3-A. May condemn land for park purposes. Said corporation shall in like manner have power to raise money to purchase land for park purposes. It shall follow the same procedure in selecting the land and paying damages, and shall have the same right of eminent domain, regulated by the same right of appeal therefrom as is provided by law for the taking of land for burying grounds.'
