### Chapter 85.

#### RESOLVE, Authorizing Release of State's Interest in Certain Lands.

Release of certain lands to C. M. Mosher. Resolved: That the forest commissioner be, and hereby is, authorized to release to C. M. Mosher of Dryden, whatever interest the state has in the easterly and westerly parts of lot numbered 5, range 4, and lot numbered 6, range 4, in Perkins plantation in Franklin county; and also in a 50 acre lot in lot numbered 5, range 3, in Washington plantation in Franklin county.

### Chapter 86.

#### RESOLVE, Authorizing Release of State's Interest in Certain Land.

Release of certain land to Clara E. Hodgkins. Resolved: That the forest commissioner be, and hereby is, authorized to release to Clara E. Hodgkins, of Farmington, whatever interest the state has in lot numbered 8, in township 15, range 6, west of the east line of the state in Aroostook county.

### Chapter 87.

#### RESOLVE, Authorizing the Forest Commissioner to Lease an Island.

Forest commissioner authorized to lease a certain island. Resolved: That the forest commissioner be authorized to lease the small island in Dark Cove in Grand Lake in Aroostook county.

### Chapter 88.

#### RESOLVE, Authorizing the Sale and Conveyance of State's Interest in Certain Lands.

Release of certain lands to William H. Soucie and Mamie Nadeau. Resolved: That the forest commissioner be, and hereby is, authorized to sell and convey to William H. Soucie and Mamie Nadeau whatever interest the state has in that portion of the public lot in township numbered 14, range 6, W. E. L. S., in Aroostook county, which is cultivated and is part of the so-called Soucie farm, reserving the gravel pit thereon, the location and size to be determined by the forest commissioner.

Approved March 20, 1933
