### Chapter 111.

**RESOLVE, Providing for a State Pension for Mary L. Merrill of Gardiner.**

Pension provided for Mary L. Merrill. Resolved: That a pension of \$12 per month be, and hereby is, granted to Mary L. Merrill, of Gardiner, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.

### Chapter 112.

**RESOLVE, Providing for an Increase in State Pension for Eva J. Rundlette of Readfield.**

Pension provided for Eva J. Rundlette. Resolved: That a pension of \$20 per month be, and hereby is, granted to Eva J. Rundlette, of Readfield, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature, and shall be in lieu of the state pension which she is now receiving.

**RESOLVE, Providing for a State Pension for Meretta McFarland of Augusta.**

Pension provided for Meretta McFarland. Resolved: That a pension of \$15 per month be, and hereby is, granted to Meretta McFarland, of Augusta, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.
