## Chapter 60.

### AN ACT Relating to the Packing of Sardines.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 41, § 78, amended. The third sentence of section 78 of chapter 41 of the revised statutes is hereby amended to read as follows:

'The minimum quantity of oil shall be not less than 4 pounds per case of 100 one-quarter size cans and the oil shall be a vegetable or cottonseed of a grade not below that of ~~Prime Summer Yellow~~ "Prime Winter Yellow Cottonseed Oil."

Approved March 22, 1935.

## Chapter 61.

### AN ACT Relating to Forcible Entry and Detainer.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 108, § 3, amended. Section 3 of chapter 108 of the revised statutes is hereby amended to read as follows:

'Sec. 3. Jurisdiction. Trial justices and judges of municipal courts have jurisdiction of cases of forcible entry and detainer respecting estates within their counties. Such justices and judges have exclusive jurisdiction of such cases within their cities or towns, unless interested; provided, however, that judges of municipal courts shall also have jurisdiction of such cases in all towns in which they are authorized to hold court notwithstanding the fact that their residence may be in some other town.'

## Chapter 62.

### AN ACT Relative to Fees for Registration of Vehicles.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 29, § 54, amended. Subdivision "a" of section 54 of chapter 29 of the revised statutes is hereby amended by adding thereto the following paragraph:

'Provided, also, that motor vehicles owned by residents of any state, province or foreign country where residents of the state of Maine registering motor vehicles are required to pay double the fees charged against resident owners, shall pay double the fees indicated above, whether for private use or for livery or hire.'

Approved March 22, 1935.
