**CHAP. 5****Chapter 2.****RESOLVE, Regulating Fishing in Pleasant Pond Tributaries.**

Fishing in tributaries of Pleasant pond, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening to fishing under the general law, the tributaries, wherever situated, to Pleasant pond; said pond being in Otisfield and Casco.

Approved February 23, 1935.

**Chapter 3.****RESOLVE, Regulating Fishing in Silver Lake.**

Fishing in Silver lake, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening Silver lake in the town of Bucksport, in the county of Hancock, to ice fishing for all fish except game fish, from the time the ice forms in the fall until the 1st day of March following; also opening said lake to ice fishing for game fish during February of each year under the general law.

Approved February 23, 1935.

**Chapter 4.****RESOLVE, Regulating Fishing in Beaver Pond, the Tributaries and Outlet Thereto.**

Fishing in Beaver pond, tributaries and outlet thereto, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening to fishing under the general law, Beaver pond and the tributaries and outlet thereto, wherever situated; said pond being in the town of Bridgton.

Approved February 23, 1935.

**Chapter 5.****RESOLVE, Regulating Fishing in Mousam Lake Tributaries.**

Fishing in Mousam lake tributaries, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening to fishing under the general law, the tributaries, wherever situated, to Mousam lake; said lake being in the towns of Acton and Shapleigh.
