**Chapter 43.****RESOLVE, Relating to Fishing in Lake Auburn.**

Fishing in Lake Auburn, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation permitting the catching of white perch in Lake Auburn in Auburn from the time the ice goes out until the following September 30th inclusive, of each year.

**Chapter 44.****RESOLVE, Relative to Regulating Fishing in Certain Somerset and Franklin County Waters.**

Fishing in Somerset and Franklin county waters, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation prohibiting all but fly fishing on Spencer stream and its tributaries, direct and indirect; and prohibiting all fishing except fly fishing on the South Branch of Dead river and all tributaries, direct and indirect, except that portion of Stratton brook which is located in the town of Eustis; and prohibiting all fishing except fly fishing in Hurricane stream, Bog brook and Jerome brook; and to establish a bag limit in all the waters open to fishing in Seven Ponds township and Massachusetts Gore township and all above named waters of not more than 10 fish in all in any one day, and not in excess of 5 pounds in all.

**Chapter 45.****RESOLVE, Closing the Tributaries of Lake Anasagunticook to Smelt Fishing.**

Smelt fishing in tributaries of Lake Anasagunticook, regulated. Resolved: That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation closing to smelt fishing the tributaries of Lake Anasagunticook in Canton and Hartford, in the county of Oxford.

Approved March 22, 1935.
