Chapter 46.

RESOLVE, Relative to White Perch Fishing in Lake Anasagunticook.

White perch fishing in Lake Anasagunticook, regulated. **Resolved:** That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation opening Lake Anasagunticook in the towns of Canton and Hartford in the county of Oxford, to white perch fishing as soon as the ice is out in the spring.

Approved March 22, 1935.

Chapter 47.

RESOLVE, Relating to Fishing in Round Pond.

Ice fishing in Round pond, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening Round pond in Albany to ice fishing for common fish from the time the ice forms in the fall until it goes out in the spring and for game fish during February and March of each year.

Approved March 22, 1935.

Chapter 48.

RESOLVE, Relating to Fishing in Songo Pond.

Fishing in Songo pond, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening Songo pond in Albany and Bethel to ice fishing for common fish from the time the ice forms in the fall until it goes out in the spring and for game fish during February and March of each year.

Approved March 22, 1935.

Chapter 49.

RESOLVE, Relating to Fishing in Pleasant River and Hapgood Brook.

Fishing in Pleasant river and Hapgood brook, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening Pleasant river and its tributaries in Mason, Bethel and Albany, and Hapgood brook in Bethel, in the county of Oxford to fishing under the general law.

Approved March 22, 1935.
