Chapter 118.

RESOLVE, Providing for a State Pension for Ashley J. Keene of Canaan.

Pension for Ashley J. Keene. Resolved: That a pension of \$10 per month be, and hereby is, granted to Ashley J. Keene of Canaan, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1935, and continue until otherwise provided by the legislature.

Approved April 6, 1935.

Chapter 119.

RESOLVE, in Favor of the Charles H. Cutter Coal Company, of Boston.

Charles H. Cutter Coal Company, compensated. Resolved: That there be, and hereby is, appropriated, the sum of \$2000 to be paid to the Charles H. Cutter Coal Company, of Boston, as a settlement in full and final payment, for loss sustained by it in the sale and delivery of 4000 tons of soft coal to the Augusta state hospital, during the coal strike in the year 1922, said sum to be paid from the general state funds.

Chapter 120.

RESOLVE, in Favor of the Chaplains of the House of the Eighty-seventh Legislature.

Chaplains of the house; appropriation for. Resolved: That there be, and hereby is, appropriated the sum of one hundred and eight dollars to be paid to the chaplains of the house of the eighty-seventh legislature, in accordance with the list filed with the treasurer of state, having been certified by the clerk of the house, same to be paid from the appropriation for the contingent expenses of the 87th legislature.

Chapter 121.

RESOLVE, in Favor of the Chaplains of the Senate of the Eighty-seventh Legislature.

Chaplains of the Senate; appropriation for. Resolved: That there be, and hereby is, appropriated the sum of \$108 to be paid to the chaplains of the senate of the eighty-seventh legislature, in accordance with the list
