#### Chapter 23

AN ACT Relating to Town Meetings of Town of Boothbay.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Date of annual town meeting of town of Boothbay changed. The annual town meeting of Boothbay shall be held on the 1st Monday of March, annually.
- Sec. 2. Repealing act. All acts or parts of acts inconsistent herewith are hereby repealed.
- Sec. 3. Effective date. This act shall take effect for the purpose of permitting the town of Boothbay to vote on its acceptance on any special town meeting called for that purpose after July 15, 1937. On the date of its acceptance by the said special town meeting, this act shall become effective in its entirety.

Approved March 11, 1937.

#### Chapter 24

AN ACT Providing for a Recorder of South Portland Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1933, c. 18, amended. Chapter 18 of the private and special laws of 1933, is hereby further amended to read as follows:

'Item VIII. Salary of judge; recorder provided for; salary. The judge of said court shall receive a salary of \$800 per year from the 1st day of January, 1925, to be paid him in quarterly payments from the county treasury of Cumberland county which shall be in full for the services as such judge. All blanks, civil and criminal, dockets and record books, required by said court, shall be furnished by the county of Cumberland. Said judge shall have authority to appoint some suitable person to act as clerk of said court whose duty it shall be to prepare and keep the records of said court and perform such other duties as the judge of said court may direct and who shall receive a salary of \$300 each year to be paid in quarterly payments from the county treasury of Cumberland county which shall be in full for services as such clerk. There shall be a recorder of said court who shall possess the same qualifications and be appointed in the same manner as the judge. He shall prepare and keep the records of the court. He shall perform all the duties of the judge
