Chapter 98

AN ACT Relating to the Ferry Between Indian Island and Old Town.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1913, c. 132, § 5, amended. Section 5 of chapter 132 of the private and special laws of 1913 is hereby amended to read as follows:

'Sec. 5. Members of tribe shall elect a ferryman. The members of the said tribe shall at their annual meeting held on the ~~first Monday in April~~ 2nd Tuesday in September of each year, elect by majority vote a suitable ferryman who shall be in charge of said ferry during the following year, such election being however subject to the approval of the agent of the tribe. The said ferryman shall not transport more than 12 persons at one trip.'

Sec. 2. P. & S. L., 1913, c. 132, amended. Chapter 132 of the private and special laws of 1913 is hereby amended by adding thereto a new section to be numbered 6-A and to read as follows:

'Sec. 6-A. Monthly report. The governor of the tribe shall call a meeting of the tribe once each month at which a report shall be made of the receipts from the operation of the ferry and the disbursements.'

Chapter 99

AN ACT Relating to Apportionment of Motor Vehicle Registration Fees Paid by Inhabitants of North Haven and Vinalhaven.

Be it enacted by the People of the State of Maine, as follows:

Motor vehicle registration fees in North Haven and Vinalhaven, apportioned. Seventy-five per cent of all fees received from the inhabitants of the towns of North Haven and Vinalhaven by the state for the registration of motor vehicles shall be spent in said towns under the supervision of the state highway commission on the roads in said towns, in each town according to the proportion the amount paid by its inhabitants bears to the amount paid by the inhabitants of both towns.
