CHAP. 19

Chapter 16

- RESOLVE, Changing the Name of Ram Island.

Ram Island renamed. Resolved: That the name of Ram Island situated in Casco Bay ½ mile more or less southeast of the shore line of the mainland of South Harpswell in the town of Harpswell be, and hereby is, changed to Pinkham Island.

Approved March 6, 1937.

Chapter 17

RESOLVE, in Favor of William Sockabesin, Representative of the Passamaquoddy Tribe of Indians.

William Sockabesin; appropriation for. Resolved: That there be, and hereby is, appropriated to be paid to William Sockabesin, representative of the Passamaquoddy tribe of Indians at the 88th legislature, the sum of \$200 for attendance and \$44 for mileage; said sums to be paid from the appropriation for legislative expenses.

Approved March 6, 1937.

Chapter 18

RESOLVE, Relating to Closed Time in Jonesport-Addison.

Closed time in Jonesport-Addison, repealed. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to repeal rule and regulation numbered 3 as it appears in the official rules and regulations of the department which were authorized by chapter 2 of the public laws of 1933.

Approved March 11, 1937.

Chapter 19

RESOLVE, Authorizing Compensation for Paul F. Fitzpatrick, of Gardiner.

Paul F. Fitzpatrick; compensated. Resolved: That the treasurer of the county of Kennebec be, and hereby is, authorized, empowered and directed to pay to Paul F. Fitzpatrick, of Gardiner, the sum of \$183.25 for additional services as recorder of the Gardiner municipal court for the period from December 4, 1936 to January 28, 1937.
