## Chapter 101

**RESOLVE, in Favor of Willis Bartlett, of Stillwater.**

**Willis Bartlett; compensated. Resolved:** That there be, and hereby is, appropriated, in favor of Willis Bartlett, of Stillwater, the sum of \$10 as a full and final settlement against the state, for damage to his house by deer; to be paid from the funds of the department of inland fisheries and game.

Approved April 17, 1937.

## Chapter 102

**RESOLVE, in Favor of Prince H. Thomas, of Masardis.**

**Prince H. Thomas, compensated. Resolved:** That there be, and hereby is, appropriated, the sum of \$50 to be paid to Prince H. Thomas, of Masardis, to compensate him for damage done to his hunting camp by bear or bears; said sum to be paid from the funds of the department of inland fisheries and game.

Approved April 17, 1937.

## Chapter 103

**RESOLVE, in Favor of Augustus D. Phillips, of Northeast Harbor.**

**Augustus D. Phillips; compensated. Resolved:** That there be, and hereby is, appropriated, the sum of \$115 to be paid to Augustus D. Phillips, of Northeast Harbor, to compensate him in full for all claims against the state for damages to his crops destroyed by deer; said sum to be paid from the funds of the department of inland fisheries and game.

Approved April 17, 1937.

## Chapter 104

**RESOLVE, in Favor of E. O. Brown, of Vassalboro.**

**E. O. Brown; compensated. Resolved:** That there be, and hereby is, appropriated, the sum of \$50 to be paid to E. O. Brown, of Vassalboro, as a full and final settlement against the state for damage by deer to his 24-acre bean patch; said sum to be paid from the funds of the department of inland fisheries and game.
