'All state officers and employees, except temporary and seasonal employees, shall be paid their salaries or wages fortnightly the dates of payment to be determined by the state controller; provided, however, that payment may be made once in each calendar month to such state officers and employees as consent to such time of payment. Temporary and seasonal employees of the state shall be paid at such times as the commissioner of finance shall specify.'

## Chapter 317

AN ACT Relating to the Duties of the Treasurer of State.

*Be it enacted by the People of the State of Maine, as follows:*

P. L., 1931, c. 216, Art. II, additional. Article II of chapter 216 of the public laws of 1931 is hereby amended by the addition thereto of a new section to be numbered 15-A and to read as follows:

'Sec. 15-A. Records; collections. It shall be the duty of the treasurer of state to receive and keep a record of all items of income accruing to the state including taxes levied by the state, and all such items shall be promptly certified to the treasurer of state by the department, bureau, institution or agency of state government where such items of income originate or by which such taxes are assessed. He shall promptly collect all taxes and accounts due the state and certified to him as provided herein. In cases of neglect or refusal to pay he shall institute through the attorney general such court actions as may be necessary to enforce payment. The provisions of this section shall not apply to the Maine unemployment compensation commission.'

## Chapter 318

AN ACT Providing for the Expiration of All Orders of the Governor's Council at the End of Its Term.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. Orders of governor's council to expire at end of its term. Chapter 2 of the revised statutes is hereby amended by adding thereto the following section to be numbered 59-A, and to read as follows:

'Sec. 59-A. Orders of governor's council to expire at end of its term. Any order issued by the governor and council shall cease to be of any effect or validity at the end of the biennium for which the council passing the order was elected.'

**Sec. 2. Limitation.** The provisions of this act shall not apply to the following classes of council orders: Orders relating to the appointment of officers and employees of the state authorized by law, or fixing their compensation, and orders authorizing contracts which may not be wholly performed during the term of the council passing such orders.
