#### 550 ORGANIZATION OF ORNEVILLE SURRENDERED

#### **CHAP. 80**

Main street to where a line drawn through the middle of Pleasant street and extended, would intersect; thence northwesterly on said line by the middle of Pleasant street to the point of beginning on Spring street.

Sec. 2. Repealing section. All acts and parts of acts inconsistent, herewith, are hereby repealed.

Sec. 3. Referendum. This act shall take effect 90 days after the adment of this legislature only for the purpose of permitting its acceptance or rejection by the legal voters of the city of Saco at the next general election therein, or at a special state election, or at any prior city election held before April 2, 1940, notified and called by the mayor and aldermen, in the manner prescribed by the charter of the city of Saco.

The question proposed on said ballot shall be substantially in the following form:

"Shall an act passed by the legislature in the year 1939 approved (insert date) entitled, 'An Act Changing Ward Boundaries in the City of Saco' be accepted?" otherwise said ballot shall be in form provided by law when a constitutional amendment is submitted to the vote of the people.

If a majority of the votes cast by the qualified voters of the city favor the acceptance of this act, it shall become operative. The city clerk shall forthwith file with the secretary of state a certificate of the action of the city thereon.

#### Chapter 80

#### AN ACT to Provide for the Surrender by Orneville of Its Organization.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Organization of Orneville may be surrendered. The organization of Orneville in Piscataquis county as heretofore adopted is hereby surrendered; provided, however, that the corporate existence, powers, duties and liabilities of said town shall survive for the purpose of prosecuting and defending all pending suits and causes of suits to which said town is, or may be a party and all needful process growing out of the same, including provisions for the payment of all or any judgments or debts which may be rendered against such town or exist in favor of any creditor.

Sec. 2. School fund and unexpended funds. The school fund deposited to the credit of said town, and all funds unexpended for school purposes at the time when this act is effective out of amounts raised by said town for

school purposes or out of amounts paid by the state for school purposes, shall be paid by the treasurer of said town or such other person in whose custody such funds may be, to the treasurer of state. Such amounts so received, shall be added to the unorganized township funds as provided in section 23 of chapter 11 of the revised statutes.

Sec. 3. Referendum. This act shall take effect 90 days after the adjournment of this legislature only for the purpose of permitting its acceptance or rejection by the legal voters of the town of Orneville at any special town meeting legally called and held before November 1, 1939, an appropriate article being inserted in the call for such meeting.

If a majority of the qualified voters of the town, present and voting, vote in favor of the acceptance of this act, it shall become operative on March 31, 1940. The town clerk shall forthwith file with the secretary of state a certificate of the action of the town thereon.

#### Chapter 81

#### AN ACT to Provide for the Surrender by Lexington Plantation of Its Organization.

#### Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Organization of Lexington Plantation may be surrendered. The organization of Lexington Plantation in Somerset county as heretofore adopted is hereby surrendered; provided, however, that the corporate existence, powers, duties and liabilities of said plantation shall survive for the purpose of prosecuting and defending all pending suits and causes of suits to which said plantation is, or may be, a party and all needful process growing out of the same, including provisions for the payment of all or any judgments or debts which may be rendered against such plantation or exist in favor of any creditor.

Sec. 2. School fund and unexpended funds. The school fund deposited to the credit of said plantation, and all funds unexpended for school purposes at the time when this act is effective out of amounts raised by said plantation for school purposes or out of amounts paid by the state for school purposes, shall be paid by the treasurer of said plantation or such other person in whose custody such funds may be, to the treasurer of state. Such amounts, so received, shall be added to the unorganized township funds as provided in section 23 of chapter II of the revised statutes.

Sec. 3. Referendum. This act shall take effect 90 days after the ad-
