Chapter 9

RESOLVE, Regulating the Taking of Smelts from Smelt Brook in the Town of Perry.

Taking of smelts from Smelt brook, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation permitting the taking by hand, from the brook locally known as Smelt brook, which brook is adjacent to the Lincoln property in the town of Perry, county of Washington, an amount of smelts not exceeding 4 quarts, at any 1 time, for his own use.

Approved March 4, 1939.

Chapter 10

RESOLVE, Relating to the Taking of Clams in Surry.

Taking of clams in Surry, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation forbidding any person not a resident of the town of Surry, in the county of Hancock, to dig clams for commercial purposes within the limits of said town. Any person taking clams contrary to the provisions of this rule and regulation shall be punished for each offense by a fine of not more than \$25, or by imprisonment for not more than 30 days, or by both such fine and imprisonment.

Chapter 11

RESOLVE, Regulating Digging of Clams Within the Limits of the Towns of South Bristol and Boothbay.

Digging of clams; regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation that it shall be unlawful for any person not a resident of the towns of South Bristol and Boothbay, in the county of Lincoln, to dig for clams within the limits of said towns, provided, however, that this regulation shall not apply to the digging of clams on the flats or along the shore of the

Sheepscoot river, so-called, within the town of Boothbay. This shall not interfere with any law relating to taking shellfish for bait for fishermen.

Whoever violates the provisions hereof shall for each offense be punished by a fine of not more than \$10, or by imprisonment for not more than 30 days.

Chapter 12

RESOLVE, Relating to the Taking of Clams in Bluehill.

Taking of clams in Bluehill, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation forbidding any person not a resident of the town of Bluehill, in the county of Hancock, to dig clams for commercial purposes within the limits of said town. Any person taking clams contrary to the provisions of this rule and regulation shall be punished for each offense by a fine of not more than \$25, or by imprisonment for not more than 30 days, or by both such fine and imprisonment.

Chapter 13

RESOLVE, in Favor of Allen C. Reed and Warren Reed, of Boothbay Harbor.

Allen C. Reed and Warren Reed; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$25 to be paid to Allen C. Reed and Warren Reed, of Boothbay Harbor, to compensate them for towing a dead body to shore; said sum to be paid from the general funds of the state.

RESOLVE, Relating to the Digging of Clams in the Town of Brooksville.

Digging of clams in town of Brooksville, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation prohibiting any person, not an inhabitant of
