Chapter 55

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Land to Mrs. Grace Shannon Moore of Macwahoc.

Forest commissioner to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey to Mrs. Grace Shannon Moore of Macwahoc, the interest of the state in a 40 acre lot of land in T. A. R. 5, W. E. L. S., Aroostook county, for the sum of \$48.09.

Chapter 56

RESOLVE, Authorizing the Sale of a Certain Interest Held by the State in an Undivided Part of Township 4, Range 3, N. B. K. P. in Somerset County.

Sale of certain land, authorized. Resolved: That the forest commissioner be, and hereby is, authorized to sell and convey to Elizabeth Blair of Erie, Pennsylvania, for the sum of \$420.50, whatever interest the state may have acquired in Bald Mountain, so-called, being township 4, range 3, N. B. K. P. in Somerset county by the sale for unpaid taxes of an undivided tenth part of 33 undivided 56th parts thereof, owned by the husband of said Elizabeth Blair at the time of his death.

Chapter 57

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Land in Washington County to Robert Bernard, Jr., of New York.

Forest commissioner authorized to convey certain land. Resolved: That the forest commissioner as land agent, be and hereby is, authorized to convey to Robert Bernard, Jr., of New York, the interest of the state in 1 acre lot of land with buildings thereon, in T. 9, R. 4, N. B. P. P. (formerly Forest City), Washington county, for the sum of \$37.10.
