Chapter 60

RESOLVE, Creating a Recess Committee on Feasibility of Acquiring Property for the Establishment of Public Bathing Beaches and for Encouraging the Development of the Shores of the Lakes and Streams of the State.

Recess committee, created. Resolved: That there be, and hereby is, created a legislative recess committee to consist of 2 members of the senate to be appointed by the president of the senate, and 3 members of the house to be appointed by the speaker of the house, to investigate the feasibility of the acquisition by purchase or gift by the state of property adjacent to the waters of the state for the purpose of establishing public bathing beaches, and for encouraging the development of the shores of the lakes and streams of the state. Said committee shall make a written report of its findings and recommendations to the 90th legislature, and in the event that said committee finds it desirable that such legislation be enacted, it shall draft a bill or bills for that purpose and cause the same to be presented to the 90th legislature. Members of said committee shall receive their actual expenses to be approved by the governor and council.

Said committee may call upon the various departments of the state for legal, engineering and other technical and clerical assistance and all departments shall furnish such assistance.

Said committee may organize an advisory council, to serve without remuneration, of one or more citizens from each county, to advise and assist the committee.

Chapter 61

RESOLVE, Concerning the Practice of Podiatry.

Fred H. Lowell permitted to file application for practice of podiatry. Resolved: That the board of podiatry be, and hereby is, authorized and directed to receive the application of Fred H. Lowell of Bangor, Maine, to practice podiatry under the provisions of chapter 140 of the public laws of 1933; provided, however, that the said Lowell shall furnish satisfactory proof to the said board that he had been engaged in the practice of podiatry a sufficient time to satisfy the requirements of said chapter 140.
