Chapter 89

RESOLVE, Creating a Recess Committee on Wage and Hour Legislation.

Recess Committee on Wage and Hour Legislation, created. Resolved: That there be, and hereby is, created a legislative recess committee to consist of 1 member of the senate to be appointed by the president of the senate and 2 members of the house of representatives to be appointed by the speaker of the house and 2 citizens of the state not members of the 89th legislature, representing industry, and 2 citizens of the state representing labor, to be appointed by the governor with the advice and consent of the council, which committee shall be known as the "Committee on Wage and Hour Legislation." Said committee shall meet as soon as convenient after appointment and organize by electing a chairman and secretary.

Said committee shall investigate and consider whether or not it is necessary or desirable for the state of Maine to enact legislation relative to minimum wages and maximum hours of employment in industry or otherwise regulating standards of employment.

Said committee shall consider and study existing federal legislation on this subject, together with laws existing in other states and countries and determine, so far as possible, the results experienced thereunder and the probable effect of such legislation upon labor, industry and the public if such legislation is enacted in Maine.

Said committee shall report its findings and recommendations to the 90th legislature and in the event that said committee finds it desirable that such legislation be enacted it shall draft a bill or bills for that purpose and have same presented to the 90th legislature.

Members of said committee shall receive their actual expenses incurred in the discharge of their duties as members thereof, said expenses to be approved by the governor and council, but such sum is not to exceed, however, the sum of \$500.

Chapter 90

RESOLVE, in Favor of Burleigh E. Bean, of Waite.

Burleigh E. Bean; state pension. Resolved: That a pension of \$12 per month be, and hereby is, granted to Burleigh E. Bean, of Waite, to be paid quarterly from the general funds of the state. Said pension shall begin July 1, 1939, and continue until otherwise provided by the legislature.
