## Chapter 102

### RESOLVE, on the Pay Rolls of the House of Representatives.

Pay rolls of the house of representatives. **Resolved:** That there be paid to the members, officers and chaplains of the house of representatives of the eighty-ninth legislature, for attendance and mileage at the special session of the legislature convened on the twenty-third day of May, nineteen hundred forty, the amounts stated opposite their respective names on pay roll lists certified to the state controller by the clerk of the house, bearing the approval of committee on appropriations and financial affairs.

## Chapter 103

### RESOLVE, on the Pay Rolls of the Senate

Pay rolls of the senate. **Resolved:** That there be paid to the members, officers, and chaplains of the senate of the eighty-ninth legislature, for attendance and mileage at the special session of the legislature convened on the twenty-third day of May, nineteen hundred forty, the amounts stated opposite their respective names on pay roll lists certified to the state controller by the secretary of the senate, bearing the approval of committee on appropriations and financial affairs.

## Chapter 104

### RESOLVE, Providing for a Recess Committee to Study the Administration of State Affairs

**Recess committee to study administrative code. Resolved:** That there be, and hereby is, created a legislative recess committee to consist of 3 members of the senate, to be appointed by the president of the senate, and 7 members of the house of representatives, to be appointed by the speaker of the house, which committee shall be known as the "Committee on Administrative Code." Said committee shall meet as soon as convenient after the appointment of its members, and organize by electing a chairman and secretary. Said committee shall study and consider the practical working of the administrative code and of those departments or agencies of the state government included within its provisions, and of all other departments

and agencies of the state government, with a view to recommending such changes in the statutes relating to the administrative code and providing for the operation of the other departments of the state as may be necessary to improve administration of the affairs of the state of Maine; and shall draft and present with its report such amendments to the present existing statutes as shall, in the judgment of the committee, be necessary or advisable; and said committee shall make a partial report to this special session and/or a full and complete report to the next regular session of the legislature, or it may file its reports with the clerk of the house during any recess of this special session. One thousand copies of either the partial or complete reports shall be printed. The committee shall be furnished an office in the state house in Augusta; the committee is authorized to employ such expert assistance as it may deem desirable, and the members of said committee shall be reimbursed for their actual expenses only; the said expenses shall be approved by the governor and council and shall be payable from the general funds of the state.

## Chapter 105

### RESOLVE, Authorizing the Sale of State's Interest in Certain Lands in Township No. 17.

**Sale of certain state land, authorized. Resolved:** That the forest commissioner be, and hereby is, authorized to sell and convey to Simeon Bouchard of St. Agatha, for the sum of \$193.57 whatever interest the state may have in 105 acres (being lots 291 and 294) of the 136 acre tract described as follows:

T. No. 17, R. 5, W. E. L. S., part of, being lots 291 and 294 of the settlers' lots, so-called, and lot B in the southeast part of said township, according to a survey and plan of said township made by E. Hanson in 1893, and recorded in the Aroostook County Registry of Deeds, Northern District; also lot E in the southeast part of said township, according to a survey of said lot made by Grover M. Hardison in 1911, delineated on said plan of E. Hanson. Said lots with the buildings thereon, are reputed to be owned by Eugene Bouchard et als and contain 136 acres, more or less.
