## Chapter 35

AN ACT Relating to the Salary for Clerks in the Office of Clerk of Courts in Washington County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 79, § 269, amended. That part of the next to the last paragraph of section 269 of chapter 79 of the revised statutes which relates to the salary for clerks in the office of clerk of courts in Washington county is hereby amended to read as follows:

'for clerks in the office of clerk of courts, ~~\$780~~ \$1,200;'

*Be it enacted by the People of the State of Maine, as follows:*

'Washington, ~~\$1,200~~ \$1,500.'

R. S., c. 79, § 269, amended. The 12th paragraph of section 269 of chapter 79 of the revised statutes, relating to the salaries of clerks in county offices of Piscataquis county, is hereby amended to read as follows :

'Piscataquis county : for clerks in the office of the register of deeds, ~~\$884~~ \$1,300 ; for clerks in the office of register of probate, ~~\$400~~ \$650 ; for clerks in the office of clerk of courts, ~~\$884~~ \$1,300.'
